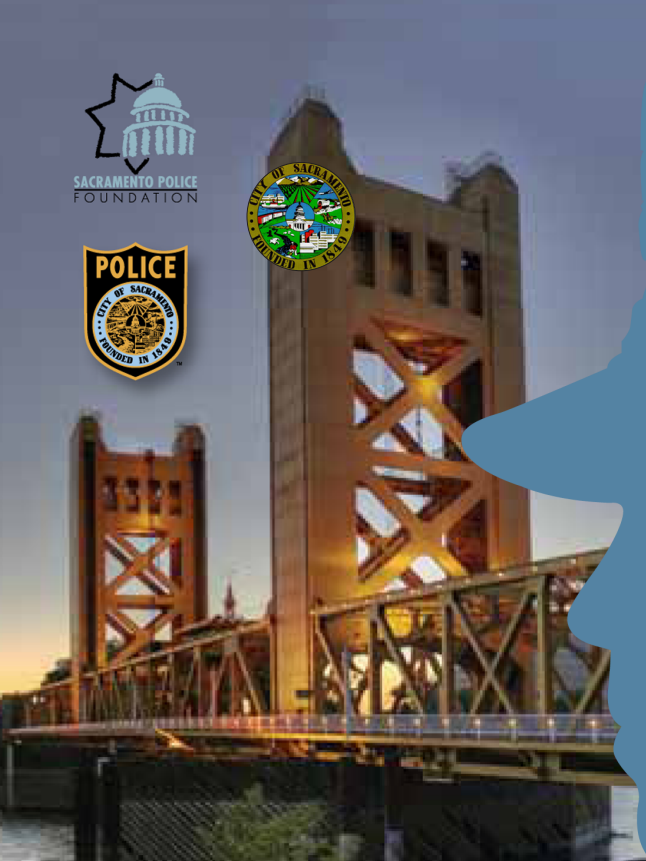

DISTINGUISHED SERVICE AWARD

Sergeants Susan Feenstra and Cindy Stinson, Officers Tera Carson and Erika Woolson, now retired Officer Kathy Fritzsche, and community members Dr. Dana Kivel and Mimi Lewis, LCSW, are being recognized for their dedicated and valuable service to the Sacramento Police Department and the city of Sacramento. Prior to 2008, street level prostitution was an ongoing complaint of residents and businesses in the Oak Park/Stockton Boulevard areas. Under the guidance of Sergeant Feenstra, the East Area Problem Oriented Policing (P.O.P.) Team, consisting of the officers listed above, routinely addressed prostitution and its negative effects of loitering and drug-related activity through enforcement and stings, without lasting effect. Their search for more successful strategies led to researching effective programs nationwide and a collaboration with the Sacramento District Attorney's Office, business leaders, a former prostitute, the Sacramento District Attorney's Office, business leaders, a former prostitute, the community, and Dr. Dana Kivel and Mimi Lewis from California State University, Sacramento.

A survey of current and former prostitutes revealed that 90% of the women had been physically or sexually abused as children and needed a "safe and non-judgmental" space to receive support, referrals, food, and basic health assistance. The

concept of the Community Against Sexual Harm (C.A.S.H.) program was born with its Oak Park drop-in center opening in May 2008. Through donations from a federal grant, The Stockton Boulevard Partnership and Oak Park Business Association, former prostitutes are employed at the center which has provided a variety of services to hundreds of women who can then find the strength and resources to leave prostitution. Due to the initiative, creativity, hard work and determination of these individuals, C.A.S.H. has played a significant role in reducing the crime of prostitution in Sacramento.



DARRYL GOULD

DISTINGUISHED SERVICE AWARD

Sergeant Darryl Gould is being recognized for his dedicated and valuable service to the Sacramento Police Department and for his contributions leading to greater efficiencies between the Traffic Court and law enforcement. While serving in the Police Department's Court Liaison Unit, Sergeant Gould recognized the need to improve processes related to scheduling officers for court and information sharing between agencies and the Traffic Court system. Sergeant Gould worked in close partnership

with the Sheriff's Department to develop a web-based, electronic scheduling and subpoena information system for use by court clerks to schedule officers. Implementation of this process has saved an estimated \$100,000 per year in officer overtime costs, increased officer appearance rates, and reduced court appearances that conflicted with officers' time off and vacations.

Sergeant Gould also established himself as leader of a team of representatives of various ranks, administrators, chief and judges from the Courts, District Attorney's Office, and local and state law enforcement to ameliorate budget constraints threatening prosecution services at the Traffic Court. One significant outcome of these team meetings was collaborating with the court to achieve access for local agencies to the Traffic Courts ICMS, the case management system at the Carol Miller Justice Center. This access provides law enforcement with ability to track and research cases, compile statistics, and receive real-time information on subpoenas and scheduling thus saving the court time in filling requests manually. Positive relations between all participants led to other outcomes including the creation of training resources for officers testifying in court, verified processes for obtaining records, and other efficiencies between law enforcement and the court. Sergeant Gould also developed several online training modules for Police Department officers to teach officers about court processes and effective testimony.

Sergeant Gould's initiative has led to more effective relationships between local law enforcement and the court, significant savings of taxpayer dollars, and a more efficient use of police officers' time.

DISTINGUISHED SERVICE AWARD

Sergeant David Valdez is being recognized for his dedicated and valuable service to the Sacramento Police Department and the city of Sacramento. As the sergeant of the Bike Unit serving the Downtown Core area, it is common to encounter the numerous events and diverse issues that are inherent to this area. In the past year alone, the Downtown Core was inundated with protests, marches, labor demonstrations, illegal homeless camps, and the infamous Occupy Movement. All of these incidents were handled safely, effectively, and efficiently due in large part to the efforts of Sergeant Valdez. He was instrumental in establishing relationships with the event organizers, labor leaders, and protestors. It was through these positive contacts that ground rules were developed and trust was established.

Because of Sergeant Valdez's uncanny ability to personally connect with people from all walks of life, whether they be homeless persons, labor organizers, or business leaders, he was able to successfully represent the interests of the City and the Police Department without creating conflict with any of these groups.

In addition to expertly handling large scale events in the Downtown Core, Sergeant Valdez worked tirelessly with the community prosecutor assigned to downtown to investigate and follow up on crime and disorder cases that directly affected the businesses and patrons to the central city. He also worked on several projects including the Serial Inebriate Program and the 7th and K Streets collective to address quality of life issues in the K Street Mall area. His impact and that of his bike team directly led to an improved feeling of safety in the Downtown Core. Sergeant Valdez developed a training course on Personal Safety that he delivered to several business and community groups. This course became so well known and received that it was requested by groups outside of the Downtown Core. The dedication Sergeant David Valdez has given to his team, the Downtown Core, and the Department has been unsurpassed.

GREG HALSTEAD ERIC SCHNEIDER *DISTINGUISHED SERVICE AWARD*

Detectives Greg Halstead and Eric Schneider are being recognized for their dedicated and valuable service to the Sacramento Police Department. During a Department CompStat meeting, the need for search warrant training was determined and made known throughout the Department. Detective Schneider, a POST-certified instructor and subject matter expert in search warrants, volunteered to take responsibility for a training project. Detective Halstead, himself an expert in writing search warrants and raid planning, joined with Detective Schneider in the development of this entirely new training.

Together, Detectives Halstead and Schneider developed a 10-hour course covering legal issues surrounding warrants, the justification for their issuance, proper raid planning, documenting and preserving seized items, and authoring legally sound warrants. Their course is made more effective by not only including lecture and case studies, but also hands-on writing of warrants with immediate instructor evaluation and a field trip to see the court filing process. To date, Detectives Halstead and Schneider have conducted 12 classes and taught over 130 students. Their students have authored over 25 search warrants on their own without having to rely on detectives. The value of their training has led Detectives Halstead and Schneider to be utilized by POST as instructors of their warrant class for officers statewide at the South Bay Regional Public Safety Training Consortium.

Officer Evan Kanenaga is being recognized for his dedicated and valuable service to the Sacramento Police Department and the Sacramento Regional Transit District (RT). In 2007, when Officer Kanenaga became manager of RT's Video Control Center, the staff consisted of officers and operators with varying degrees of training and ability to process and perform video requests and follow up on observed problems. Officer Kanenaga, who is still assigned to RT, initiated a number of changes in personnel, training, and operations that resulted in greater efficiency and improved operations.

Officer Kanenaga made improvements that included drafting policies and procedures, training staff and educating end users, as well as installing better equipment, utilizing volunteers, and creating new operations. Calls for service, video requests processed and recovered, and ID checks have all increased due to Officer Kanenaga's operational changes and better tracking.

Through his initiative, hard work and vision, Officer Kanenaga's improvements resulted in better RT police services and a more effective Video Surveillance Program with a higher enforcement rate, lower crime rate, and reduced staffing costs.

In the early morning of January 31, 2011, Sacramento Police Department Dispatch received a call from a woman stating that her boyfriend had been assaulting her as he drove them around the north Sacramento area while threatening to kill her. Officers John Gresham and Anthony Pennington were the first to respond to the house as the victim reported to Dispatch that her boyfriend had hung himself in the garage. They found the female victim bleeding from her injuries from the assault, then went to the garage and saw the suspect hanging from the rafters by a heavy-duty outdoor extension cord. The suspect's body was limp; he was not breathing, and his feet were not supported.

Officer Pennington stood on a chair to lift the full weight of the hanging man. As Officers Pennington and Gresham supported the suspect's weight, he began to struggle to breathe. Officers Derick Cannedy and Johnny Lopez arrived in the garage and assisted in lifting the man as Officer Gresham struggled to unwrap the tightly wound cord from the suspect's neck. Medical assistance was requested while the officers continued to support the suspect. Officer Lopez went into the kitchen for a knife to cut the cord, at which point Officer Pennington used his own pocket knife to cut through several strands of extension cord. The officers were then able to place the suspect on the ground and remove the cord from around his neck. The suspect was transported to the hospital, treated, and released days later.

On the morning of April 30, 2011, Officer Randy Van Dusen parked his patrol car on the American River levee as runners from a half marathon event passed by. As Officer Van Dusen prepared to leave, a runner collapsed in front of him. Thinking the runner had tripped or stumbled, Officer Van Dusen walked down the trail to check on the fallen runner. He found that the runner had suffered a heart attack and was unconscious with no pulse. Officer Van Dusen immediately called for Fire/Medical assistance and began chest compressions. Within minutes, other runners arrived, some medically trained. They checked for the runner's pulse while Officer Van Dusen continued chest compressions. Each check revealed no pulse or response, and Officer Van Dusen was finally advised to discontinue chest compressions. Officer Van Dusen refused to give up and continued.

Several minutes later, and prior to medical aid arriving, the victim's heart began to beat. Later, the victim's wife said that at one point it seemed all hope was lost, but Officer Van Dusen's unwavering commitment gave her a thread of hope to which to cling. Fire/Medical personnel stated that, without question, Officer Van Dusen's actions and commitment saved the runner's life. Officer Van Dusen's commitment to assisting the victim and his wife continued when he checked on them at the hospital later that day. The runner was in ICU and the out-of-town couple's belongings remained in their motel room past checkout time. Officer Van Dusen went to the motel, explained the situation to the motel manager, and obtained the couple's belongings, which he delivered to them at the hospital. Over the next several days, Officer Van Dusen continued to check on the victim.

In the early afternoon of June 17, 2011, Sacramento Police Department Dispatch received a call that a man appeared to be trying to hang himself using a bike lock on the Highway 99 footbridge near 32nd Street and 8th Avenue. Sergeant Paul Freeman and Officers Shannon Whent and Ryan Ley were first to arrive on scene and found the subject as described. Officer Ley called for bolt cutters to bring him down. Sergeant Freeman retrieved the bolt cutters, cut the bike cable and then assisted the officers in bringing the subject down. The subject was not breathing, his eyes were bulging with a glazed lifeless look in them, and his tongue was hanging out of his mouth. He had no pulse or heartbeat.

Officer Whent began chest compressions, and Detective Chris Mouzis, who had been monitoring the situation and was nearby, responded with a mask, which he used to administer breaths to the subject. After 2-3 minutes of CPR, Officer Whent detected a pulse and a heartbeat. After continuing CPR for an additional 2-3 minutes, the subject began breathing on his own. He was no longer lifeless after the officers performed CPR for approximately six minutes until the Fire Department arrived to take over. Paramedics checked his vitals and found that he had a strong heartbeat and was breathing well on his own. He was taken to the hospital where it was stated that the officers did an excellent job and that their CPR efforts were critical to the man's survival.

On the evening of November 20, 2011, Sacramento Police Department Dispatch received a call from a young man that his mother had called him saying, with her speech slurred, that she was going to die that night. Officers John Morris and Craig Wetterer responded immediately. Upon arriving at the mother's house, they received no answer at the front door, but could hear agitated dogs barking inside. Looking in, Officers Morris and Wetterer could see two very large boxer type dogs jumping at the front door due to the officers' presence. Upon further investigation around the home's perimeter, they could hear a car engine running inside the attached garage.

Fearing for the safety of the occupant based on the call Dispatch had received, Officer Morris immediately forced open the front door to gain entry into the house. The officers were charged by the dogs, but were able to fend them off and direct them to the backyard. The barely conscious victim was located in her vehicle which was parked in the garage. A garden hose was attached to the vehicle exhaust pipe and led into the vehicle which had both doors and all windows closed. Officers Morris and Wetterer were able to remove the victim from her car and into fresh air to await paramedics. The Fire Department arrived and transported the victim to the hospital where she was treated for potentially fatal exposure. Fire personnel stated that there were extremely toxic levels of carbon monoxide, which both officers were exposed to, inside the garage and home.

Volunteer Penn Yee is being recognized for her dedicated and valuable service to the Sacramento Police Department and the Sacramento community. Ms. Yee began her volunteer service with the Police Department over 14 years ago, in October 1997, writing reports. In 2002, Ms. Yee became one of the original Volunteers in Police Services (V.I.P.S.) when that program began.

Ms. Yee became a welcoming addition to the public lobby at the Police Department's headquarters when she established the greeter desk position in 2008. In 2009, she established a greeter desk at the Department's Central facility. Between the two facilities, Ms. Yee dedicates nine hours per week of her time to greeting and directing members of the public. Ms. Yee is also the lead volunteer at all Department DUI checkpoints, and regularly volunteers for the Police Department at a variety of events such as police memorial services, large scale bike races and marathons, open houses, youth and athletic events, and at the State Fair. Ms. Yee represents the Police Department on the Law Enforcement Volunteers of California board attending their monthly meetings and planning the LEVOC annual conference of over 500 police volunteers.

Demonstrating her initiative, dependability and concern for others, Ms. Yee volunteered 670 hours in 142 shifts during 2011.

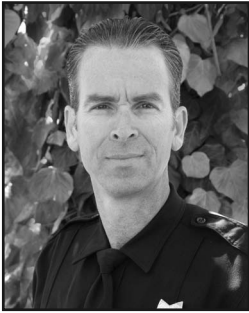

In 2011, Sergeant Nutley led the Crime Suppression Team at the Central station and through his leadership, his team had tremendous success in their proactive work on crime series, patterns, and crimes in progress. Sergeant Nutley not only inspires his officers to perform to the best of their ability, he challenges them to do the same in other areas. He encourages participation in activities such as Baker to Vegas, Eppie's Great Race, California International Marathon, Race Across America, and other sporting events that have a law enforcement or public safety category. Aside from the benefits of fitness and personal well-being, he believes these opportunities allow officers to get closer to the community by showing there is more to police officers than just enforcing laws.

In addition to the numerous fitness activities, Sergeant Nutley is a well-respected facilitator who has been instrumental in the success of the Department's Frontline Leadership course.
